The offer is also consistent with the credit volume and award type as prescribed in the Level 5 award standard for Pre-Higher Education Foundation Awards for International Students.

### **3.2 Letterkenny Institute of Technology (LYIT)**

At the April PAEC meeting the Committee discussed the PhD validation request from LYIT pending the imminent establishment of ATU.

The Committee noted that the executive has engaged with the South East Technological University and all of the recently established TUs to ensure an orderly administrative handover of the QQI register of PhD students, consistent with the transition awarding arrangements under the TU Act.

FIT indicated that this timeline would ensure that it could plan for concluding these review processes sustainably.
